#### Notes:

The following conditions apply when providing technological assistance:

\* For services provided outside the city of the Provider's office, the Customer shall provide transportation.

\*\* For services provided outside the established working hours, the hourly rate shall be increased according to the requirements of the Labor code.

\*\*\* The monthly fee includes the issuance of 600 (six hundred) TST certificates per month.

### 4. Provision and use of certificates for electronic signature and related services

#### 4.1. Amendments to the tariff

- 4.1.1. The Provider shall maintain a tariff for the provision and use of B-Trust certificates for electronic signature.
- 4.1.2. The Provider may unilaterally amend the tariff at any time of the contract, notifying the Titular by publishing the changes on their website <http://www.b-trust.bg> or by personal notification. The change shall be effective for the Titular from the day following the day of publication, respectively the receipt of the notification.
- 4.1.3. Within 5 (five) days from the date of the amendment under item 4.1.2 and as far as there is an increase in prices, the Titular has the right to terminate the contract unilaterally as of the expiration date of the last certificate by sending a written notice to the Provider. In this case, the contract shall be considered terminated from the date of the amendment, and the fees paid under the contract for the use of service(s) are not refundable.
- 4.1.4. In the absence of a notice of termination, the Titular shall be deemed to have agreed to the amendment.
- 4.1.5. The amendment shall not affect already paid one-time remunerations or periodic prepaid remunerations. In these cases the Titular cannot terminate the contract under the conditions of item 4.1.3.

#### 4.2. Use of Cloud QES

- 4.2.1. Cloud QES certificates are issued and used only with a prepaid package included.
- 4.2.2. Cloud QES certificates are used only through the B-Trust Mobile application available for download from App Store and Google Play.
- 4.2.3. The archive of the documents signed with Cloud QES and the history of their use are

available only with a valid certificate.

#### 4.3. Free services

The Provider offers free of charge registration and information services related to the use of the Public Register, as follows:

- 4.3.1. Access for verification and downloading a certificate of the Titular and Author published in the register, when the certificate is not loaded in the computer of the Titular or the Author.
- 4.3.2. Access for verification and downloading the Certificate Revocation List maintained by the Provider.
- 4.3.3. Access for verification and downloading the Provider's certificates (B-Trust Domestic Root CA. B-Trust Operational CA1).
- 4.3.4. Access for downloading public documents of the Provider.

#### 4.4. Invoicing

- 4.4.1. The Provider shall issue an invoice to the Titular for provided services.
- 4.4.2. For the use of the services - "Issuance and maintenance of a certificate", "Renewal of a certificate" and "Re-issuance of a certificate" a one-time fee is paid when requesting the service or within 5 days of receiving the invoice.
- 4.4.3. For the use of the services "Prepaid packages for the use of Cloud QES", a one-time fee is paid at the time of their requesting.
- 4.4.4. When using the services "Technological assistance in the installation of B-Trust products and services", "Technological assistance in the installation of B-Trust products and services and work with public electronic portals (NRA, NSSI, Commercial Register, etc.)" and "Technological assistance in installation of B-Trust products and services in the office of BORICA AD", the service is measured on a "man-hour" basis and is paid on the basis of a bilaterally signed protocol for work performed. The prices of the hourly rate in the attached Tariff are valid within the established working hours from 8.30 am to 5.30 pm on working days. When working outside the established working hours, the prices are increased by a corresponding percentage, according to the Labor Code.
- 4.4.5. All amounts due are paid in cash or by bank transfer. Payment by bank transfer is considered made by crediting the bank account of the Provider with the full amount due.
